Police Report

Councillor S. J. McCormick reported that the following information had been received from the Police:

 Anti-Social Behaviour has increased and targeted patrols are to take place to monitor what is going on and identify the persons involved. If youths are caught, they will be spoken to in front of their parents.

Partnership Report

Councillor Henderson reported that a poorly attended meeting had been held recently. Members of Burnhope Cricket Club had raised issues concerning the erection of the marquee for the "Fun Day" and the lack of helpers. Concern had also been expressed about the storage of the marquee, as the container had been moved.

Whilst profit from the "Fun Day" had been down on the previous year, the event had still been a success with community engagement.

Community Centre Report

McMillan Coffee Morning had been successful with more than £600 raised.

Plans are in hand to provide a small coffee shop on the premises and, hopefully, provide an outdoor seating area.
