Police Report

PCSO L. Jackson presented the Police Report as follows:

- Problems with quad bikes being ridden in the village ongoing investigation.
- Mini Police been working with Speedwatch and have also visited Spennymoor Police Station.
- Stolen mini vehicle enquiries are ongoing.
- Drain cover stolen.
- Speed laser gun used at Holmside and verbal warnings given.

Partnership Report

Councillor K. Barron presented the report as follows:

Community Centre Report

Councillor J. Box reported as follows:

- Plans to be included in the next newsletter.
- Area Action Partnership Grant received towards funding. At present the shortfall is £5,800.

War Memorial

Members were advised that a grant of £63,300 had been approved by the War Memorial Trust. This leaves a shortfall of £8,000. The Area Action Partnership had asked the Parish Council to provide £2,000.

The Area Action Partnership had asked the War Memorial Trust to pay the grant to Durham County Council so that it might provide the VAT funding shortfall which could not be met by the Parish Council.

It was unanimously Resolved that:

- 2. £2,000 be provided by the Parish Council as requested by the Area Action Partnership.
