Apologies for Absence

Apologies for absence were submitted on behalf of Councillors T. Clarke, P. Luther, S. J. McCormick, C. McCulloch, I. McKeag, County Councillor D. Oliver and PCSO C. Milner.

Durham County Council Award

The Chair congratulated Councillor L. Clarke who had recently been awarded an honour by Durham County Council for her voluntary work in the community.

Police Report

The Clerk read out the following Police Report:

- PCSO's 30136 and 8740 attended Burnhope primary school on two occasions.
 Pupils from years 5 and 6 were educated about Internet safety etc. Younger pupils were told about the roles of the Police after which they were given a tour of a Police van.
- An incident of Anti-Social Behaviour was addressed by officers where youths had caused a nuisance outside a property. One youth was identified, and a home visit undertaken. The youth in question wrote a letter of apology which was given to the resident who was satisfied with the outcome.
- Two "Off Road" bikes were spotted being driven on footpaths in an unsafe manner. Following investigation officers spotted one of the riders on foot and followed him to an address. When the rider was stopped, by officers three males were reported for obstructing the Police when doing their duty.
- A letter had been received from a resident regarding the increased use of "Off Road" bikes, together with a reply from PCSO Milner. The resident was encouraged to report all such incidents.
- Officers confirmed that, they too, had noticed an increase in the number of "Off Road" bikes in Burnhope and encouraged the public to report all incidents involving such bikes.

Partnership Report

Work has started on most of the allotments, despite the poor ground conditions.
 Most of the sheds are now in a state of disrepair.

Community Centre Report

 Mr Gibson advised that all Groups are expanding. The Lunch Club is doing well. Outside furniture has been ordered.
