Minutes of a meeting of Burnhope Parish Council held on Thursday 4th November 2021 in Burnhope Community Centre at 6:00 pm.

Apologies for Absence

Apologies for absence were submitted on behalf of Councillors B. Henderson and I. McKeag and PCSO Tonge.

Heritage Walks

The Chair welcomed Kieron Young to the meeting. Kieron was present to explain a scheme which will bring about one hundred Heritage Walks throughout the County.

It was hoped that, with the backing of the Parish Council, Burnhope would be one of the first walks to be introduced.

The walks would use existing Public Rights of Way and it was hoped to involve the local community (with its knowledge of local heritage) in planning the routes. It was anticipated that the walks would be publicised and would, as a result, attract people to the area.

It is intended that walkers will look to "tick off" the walks (most of which will be approximately 8 to 9 miles long) once they have been completed.

The route of each Heritage Walk will be "waymarked" using five feet high oak posts which would depict the area in which they were located. For example, the Burnhope posts could show the Pit Wheel and the communication mast

Members unanimously supported the initiative, and it was **Agreed** that a short meeting should be arranged followed by a walk to examine possible routes.

It was also **Agreed** that Councillors McCormick and McCulloch should lead on this initiative and report back on progress to the Council.

Marcel Bone advised that there was already a Tuesday morning Walking Group in Burnhope and he anticipated that its members would probably want to be involved.
