Planning Matters

The Clerk reported on the following:

Planning Application received by Durham County Council
Chad House, Holmside Lane, Burnhope – demolish garage and construct new garage with
residential annexe above consisting of lounge / kitchen, bathroom and bedroom – No objection.

Planning application approved by Durham County Council: 17/2736 – 80 Meadowfield, Burnhope, Change of Use from C3 dwelling house to C2 Residential Institution (Safe Haven for young children).

The Clerk reminded Members that, at an earlier meeting, the Parish Council had agreed to send an objection to the proposal to Durham County Council. The objection had subsequently been considered by the County Council's Planning Committee.

The Clerk reported that a number of local residents had asked the Parish Council to support their efforts to have the decision overturned and advised that if the Parish Council was to support the residents it could involve a Judicial Review which would be an extremely expensive action which could, theoretically, "bankrupt the Council".

The Clerk, therefore recommended that Members should not pursue such a course of action but should accept the County Council's determination of the Planning Application.

The Clerk continued by reminding objectors that as the decision had been taken earlier there remained only a period of approximately 7 days in which to appeal the decision. He also advised the objectors that if the decision was appealed they would be well advised to appoint a Solicitor / Barrister specialising in planning law.

After further advice and discussion, a vote was taken, and it was unanimously **AGREED** to accept the decision of Durham County Council in respect of Planning Application 17/2736 and decline to be involved in any attempt to overturn the decision.

Precept 2018/2019

The Clerk reported the receipt of correspondence from Durham County Council providing details of the Parish Tax Base and a request for the Parish Precept for the financial year 2018/2019.

Details were given in respect of the Local Council Tax Reduction Scheme grant figure for 2018/2019 in the sum of £548.00.

It was unanimously **RESOLVED** that Burnhope Parish Council agree a precept in the sum of £6,300.00 for the financial year 2018/2019.
