Chair's Remarks regarding 2022/2023

Councillor Coates began his Remarks with some thanks:

- Thank you, Peter Hughes, our Parish Clerk, for the work he carries out with Parish Council business and keeping a rein on me.
- Thank you to Jan Box, Vice-Chair and all Members of Burnhope Parish Council for their trust and help in allowing me to lead Burnhope Parish Council and a huge thank you to Alderman Ossie Johnson and Councillor Gordon Smith. Ossie for his guidance and wealth of expertise and experience and Gordon for his technical input whether in relation to electrical work or engineering his help is truly appreciated. Thank you also to Alan Gibson who volunteers to help with our flower tubs, War Memorial and who is a massive asset and help to me during the organising and presentation of our Remembrance Sunday Ceremony.
- Thank you also to County Councillors Mike McGaun and Douglas Oliver for their input and attendance at our meetings.
- Thank you also to Andrew Tonge who has recently left our Police Beat Team.
 Andrew was a huge help within our village during his time here and welcome to PCSO Paige Hart who has taken over from Andrew.

Councillor Coates said that, whilst during the last ten years, (since he was elected as Chair), the Parish Council has had its ups and downs, his Remarks submitted to Annual Meetings had always been upbeat and positive until those submitted to this meeting held on 4th May 2023.

The Chair felt that 2022/2023 began in the usual manner, then towards the end of 2022 the Council was hit with the Planning Application from BP Solar for permission to install a Solar Farm twice the size of Burnhope village. Objections numbering more than four hundred were submitted for various valid reasons only to be dismissed by Durham County Council with the result that this monstrous development has been approved.

Councillor Coates said that he could only shake his head and ask what Burnhope Parish has done for Durham County Council to allow this development to happen.

The Brownfield Land Release Fund promise whereby Durham County Council was to build Social and Private Housing on the Greenwood Avenue site has, it would appear, stalled. We are told that money is the issue yet building development is happening throughout the local area. Councillor Coates' mind boggles. However, he suggests, people have good memories.

Councillor Coates continued by reminding everyone that, as Burnhope Parish Council always has done, it will continue to serve the Parish and Village, for example:

- Supply the lighting for the village Christmas Tree.
- Keep flower planters bright and colourful.
- Maintain the roadside seating and Gateway fencing.
- Maintain the upkeep of the Parish Cemetery. (Thank you to Derwentside Tree and Garden Services for their attention to detail in this area)
- Continue lobbying with regards to amendments to speed limits on Edge Lane / Langley Lane and junctions, this on top of the "Dangerous Junction Sign " which was sited last year after a long delay.
- Attempt to educate a minority of dog owners to pick up their dog's waste and "Bin it" and not to leave it on footpaths for Villagers to tread in.
- Try to support as much Parish activity as possible.
- Support the Woodland Creation / Living Woods venture.
- Support the Heritage Walks 100 scheme which was presented to us by Kieran Young.
- Develop the play area adjacent to Burnhope Cricket Club with new equipment.

Councillor Coates concluded by asking everyone to keep smiling and be positive through these difficult times.

Community Centre Report

The Clerk submitted the following report:

- Kids Klub for primary school children restarted in March 2023. There are thirty members, so the Klub is full. A waiting list is to be started.
- Easter school holiday events in partnership with Karbon Homes were a real success. Around twenty-five children attended each day and some new people.
- Easter Funday approximately two hundred people through the door raising £731 for a range of charities including about £500 for Burnhope Community Centre.
- Wednesday Lunch Time Social is continuing with around fifteen people attending each week.
- Supper Club in partnership with Burnhope Primary School, St. John's Church,
 St. Nicholas' Church, Durham, and Feeding Families family cooking.

Tuesday and Thursday afternoons from 3-30 until 5-30 p.m. Started on 25th April 2023 and is going really well.

- Heritage Day, Saturday 20th May 2023 from 10-00 until 5-00 pm, all welcome.
- Planning May 2023 school holiday activities Water Fun Day and Teddy Bears' Picnic
- Working with Burnhope Partnership members to plan the Summer Fayre (Monday 28th August 2023).
- Hall nearly fully used by community groups and activities. No users pay room hire charges due to grants received to ensure that local people can afford the activities.

Correspondence

The Clerk reported on the following items of correspondence:

- Burnhope School request for donation. For school activities in connection with Burnhope Heritage Week. Agreed to donate £500.
- Durham County Council and Lottery Community Fund Approval of all funding for replacement play equipment. Members welcomed the award of all funding. It was agreed that the Clerk should write to Councillor Box to thank her for all the hard work she had undertaken to secure the funding along with officers from the Area Action Partnership. Also, to thank her for her work as Vice-Chair in recent years.
- County Durham Association of District Councils Draft recommendations for new electoral arrangements in County Durham. The number of County Councillors to be reduced from 126 to 98.

The current Lanchester Division, of which Burnhope is part, will become a one Member ward with Healeyfield Ward removed from the current Division.

The Boundary Commission is to retain the Division name of Lanchester but will welcome comments as to whether the inclusion of Burnhope in the name would be appropriate. Following consideration of the proposals it was **Resolved** that:

- The Parish Council agrees to support the Draft Recommendations in respect of the Lanchester Division.
- ii. The Parish Council recommend that it would be wholly appropriate to include "Burnhope" in the name of the Electoral Division. It is felt that the inclusion of the name of the village would give Burnhope and its residents a sense of identity.
- Lightsource BP The Clerk reported the receipt of an e-mail, by the Chair, from Lightsource BP. Attached to the e-mail was a Community Benefit Offer in relation to the Burnhope Solar Farm at Edge Lane, Burnhope which was recently granted Planning Permission. Such payment to be applied towards a project or projects to benefit the local community at the discretion of Burnhope Parish Council.

To offer the following Benefit Payment to the Parish Council:

A single payment of £1,000 per Megawat of installed capacity, subject to the approved final design, to be paid after construction and connection of the development.

Resolved that Burnhope Parish Council formally accepts the offer of the Benefit Payment as detailed above.

Parish Garden Competition

Councillor Metcalf invited Members to consider organising Parish Garden Competition. He appreciated that it was not possible to do this for 2023.
