Minutes of a meeting of Burnhope Parish Council held in Burnhope School on Thursday, 6th April 2017 at 6:00 p.m.

Apologies for Absence

Apologies for absence were submitted on behalf of Councillor G. Smith.

War Memorial

Andy Coulthard of the Area Action Partnership was in attendance to provide information about the budget and cash flow projections for the War Memorial project. Copies of the documents were circulated. Mr. Coulthard reminded Members that they had previously agreed to contribute £2,000 towards the overall cost of the scheme.

Other funding was as follows: -

Contributor	Contribution £
War Memorial Trust	63,330.00
Neighbourhood Budget	10,239.00
County Durham Community Fund	3,000.00
Heritage Lottery Fund	9,700.00

The meeting was advised that it was necessary for the Parish Council to contribute a further £2,428 to the County Council but this could be reclaimed via the County Durham Community Fund grant to the Friends of the War Memorial,

RESOLVED that:

- 1. The funding position be noted and that the Parish Council's total contribution to Durham County Council in connection with the War Memorial Project be in the sum of £4,428 as set out above.
- 2. Andy Coulthard be formally thanked for his work on this project.
- 3. A letter of thanks be forwarded to Peter Dunn of Durham County Council for the work he had undertaken on this project.

Police Report

PC I. Nelson presented the Police Report as follows:

- Problems with motor bikes and guad bikes.
- Mini Police continued to work with Speedwatch and have also visited Spennymoor Police Station.
- Parking problems, Meadowfield volume of traffic.
- Speed laser gun currently being re-calibrated.
- Fire at Wardles Bridge Inn.

Partnership Report

Councillor Henderson advised that there was one vacant allotment. Applications were still being submitted for grants.

Community Centre Report

Councillor J. Box advised that the closing date for tenders relating to the Community Centre building work was 21st April 2017.

If the 5-year option was taken up it would produce a saving (compared to the 1 year option) of approximately £675 over the 5-year period. Members were advised that the War Memorial / Memorial Garden were to be covered in the sum of £200,000.

RESOLVED that the Council approves the five-year option detailed above in the sum of £1324.46 per annum and notes the situation regarding insurance cover for the War Memorial / Memorial Garden.
