Minutes of a Remote (Zoom) meeting of Burnhope Parish Council held on Thursday 3rd September 2020 at 6:00 p.m.

Apologies for Absence:

Apologies for absence were submitted on behalf of Councillors H. Barron, K. Barron, F. Dawson and G. Smith.

Langley Lane / Burnhope Crossroads

The Chair detailed a proposed road safety improvement scheme put forward by Durham County Council in relation to Road C10 Langley Lane / Burnhope Crossroads.

The proposal included the following:-

- Proposed buff anti-skid surfacing to be extended and renewed.
- Vegetation to be trimmed to improve visibility.
- Proposed flag direction signs to be installed to be in drivers' eyeline.
- Speed limit to be raised from 30 mph to 40 mph.

Considerable discussion of the proposals ensued, with some members expressing real concern at the proposal to increase the speed limit.

It was pointed out that several residents are totally opposed to the increased speed limit. In this connection a petition had been submitted to the County Council.

Whilst Members, generally, supported the scheme which it was felt would improve road safety, they were totally opposed to the proposed increase in the speed limit.

Following a vote it was **RESOLVED** that Burnhope Parish Council rejects the scheme on the grounds of the proposal to increase the speed limit from 30 mph to 40 mph.

Partnership Report

Councillor Henderson reported that the allotments were doing well.

Community Centre Report

Councillor Box informed the meeting that the Community Centre had now re-opened with various groups slowly coming back.

Interviews would soon be held for the post of Community Centre Coordinator.
