## **Planning Matters**

The Clerk reported upon the following Planning Application received by Durham County Council:

Planning Application 22/1769 - Land East of Edge Lane, Maiden Law – installation and operation of a ground-mounted photovoltaic (PV) solar energy generation system (Solar Farm), battery storage facility, electrical substation and associated infrastructure.

The Clerk advised that the applicants had offered to attend the Parish meeting to answer questions etc that Members may wish to submit. Members felt that with information previously circulated and the public presentation and the detail planning application this would not be necessary.

Considerable discussion took place on this application, particularly with regard to the scale of the development and its likely impact on Burnhope village.

Members of the public who attended the meeting outlined their objections to the proposal.

A vote was taken, and it was unanimously agreed to object to the proposed development on the following grounds:

- The overall scale of the development is considered totally excessive. It is almost two and a half times the size of Burnhope village.
- It will have a seriously detrimental impact on local residents, particularly those living to the north of the village.
- It will have a detrimental impact on wildlife given its proximity to a local nature reserve.
- A possible loss of public footpaths in the area as a result of the erection of security fencing around the proposed development. It should be noted that the footpaths in this area are regularly walked by local residents. The network of footpaths means that the area, which is relatively flat, is easy to get around.
- · Loss of agricultural land.
- Despite such a large-scale development there is no evidence to suggest that any local jobs will be created i.e. during the construction period or ongoing maintenance should the scheme become operational.

- Loss of connectivity (established Nature Corridors) for wildlife between the various woodlands and ponds in the area in question.
- The Parish Council is of the opinion that the Planning Gain to local residents is derisory. The fact that the site is scheduled to be in use for forty years means that the annual "Gain" is only £1,000.

Whilst the Parish Council was unanimous about these objections to the proposed development, it asks, that if, the Planning Committee is minded to approve the application, it should look to secure larger financial Planning Gain for the residents of Burnhope.

In conclusion, Burnhope Parish Council asks that the application is refused on the grounds detailed above.

## Correspondence

The Clerk reported upon the following items of correspondence:

- Durham County council re footpath access to Chapman's Well Local Nature Reserve. The landowner has been asked to remove the boulders. Enquiries being made to identify alternative methods of access control which should prevent the unlawful use of Quad Bikes in the locality.
- County Councillor Oliver re fire damage to woodland north of the village. The issue has been flagged up with both the local PCSO and the "Fire Brigade."

# Queen's Platinum Jubilee Beacons event

The Chair reported the receipt of a "Certificate of Grateful Recognition" in respect of the Parish Council's participation in the Queen's Platinum Jubilee Beacons event held on 2<sup>nd</sup> June 2022.
